In persuance of the provisions of clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of the Uttaranchal Appropriation (Vote on Account) Act, 2001 (Uttaranchal Adhiniyam Sankhya 4 of 2001). As passed by the Uttaranchal Legislative Assembly and assented to by the Governor on May 5, 2001.

THE UTTARANCHAL APPROPRIATION (VOTE ON ACCOUNT) ACT, 2001

to provide for the withdrawal of certain sums from and out of the Consolidated Fund of the State for the services for a part of year beginning on the first day of April, 2001.

ACT

IT IS HEREBY enacted in the Fifty-Second Year of the Republic of India as follows:--

1. This Act may be called the Uttaranchal Appropriation (Vote on Account) Short title Act. 2001

Issue of Rs. Consolidated Fund of Uttaranchal for the year 2001-2002

2. From and out of the consolidated Fund of Uttaranchal there may be withdrawn 11902564000 sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate to the sums of Rs. 11902564000 (One thousand One hundred ninty crore twenty five lakh and sixty four thousand only) towards defraying the several charges which will come in course of payment during the year beginning on the first day of April, 2001.

Appropriation

3. The sums authorised to be withdrawn from and out of the Consolidated Fund of Uttaranchal by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
