ACT, 2014**

(Act No. 22 of 2014)

To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State to the services for the year ending on thirty first day of March, 2015

IT IS HEREBY enacted in the Sixty-Fifth year of the Republic of India by the Uttarakhand State Legislative Assembly –

Short Title	1- This Act may be called the Uttarakhand Appropriation (First Supplementary 2014-2015) Act, 2014.
Issue of Rs. 38189288000 out of the Consolidated Fund of Uttarakhand for the year 2014-2015	2- From and out of the Consolidated Fund of Uttarakhand, there may be paid and applied sums not exceeding those specified in colum-3 of the Schedule, amounting in the aggregate to the sums of Rs 38189288000 (Rs Three Thousand Eight Hundred Eighteen Crore Ninety Two Lakhs Eithy Eight Thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the thirty first day of March, 2015 in respect of the services and purposes specified in colum-2 of the Schedule.
Appropriation	3- The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttarakhand by this Act shall be appropriated for the services and purposes, expressed in the Schedule, in relation to the year ending on the thirty first day of March, 2015.
