| Amendment of Title, long title and short title | 2. | In the Uttarakhand Commission for the Scheduled Castes, Scheduled Tribes Act, 2003 (Act no. 08 of 2003) hereinafter to referred as the principal Act, the words “Scheduled Tribes” in the title, the words “and Scheduled Tribes” in the long title and the words “Scheduled Tribes” in the short title shall be repealed. |

- Amendment of Section 2** 3. In Clause (f) of Section 2 of the principle Act, the words "and Scheduled Tribes" and the words "and Scheduled Tribes" shall be repealed.
- Amendment of title of Chapter-II** 4. In title of Chapter-II of the principle Act, the words "Scheduled Tribes" shall be repealed.
- Amendment of Section 3** 5. In Section 3 of the principle Act, the words "and Scheduled Tribes" shall be repealed.
- Amendment of Section 4** 6. In Section 4 of the principle Act-
- (a) in sub-section (1) the words " /Scheduled Tribes" and the words " or Scheduled Tribes" shall be repealed.
- (b) in sub-section (2) the words "and Scheduled Tribes" shall be repealed.
- Amendment of Section 5** 7. In Clause (f) of sub-section (3) the Section 5 of the principle Act, the words " , Scheduled Tribes" shall be repealed.
- Amendment of Section 10** 8. In Section 10 of the principle Act, the words " , Scheduled Tribes" shall be repealed.
- Amendment of Section 11** 9. In sub-section (1) of Section 11 of the principle Act--
- (a) in clause (a), the words "and Scheduled Tribes" shall be repealed.
- (b) in clause (b), the words "and Scheduled Tribes" shall be repealed.
- (c) in clause (c), the words "and Scheduled Tribes" shall be repealed.
- (d) in clause (e), the words "and Scheduled Tribes" shall be repealed.
- (e) in clause (f), the words " , Scheduled Tribes" shall be repealed.
- Saving** 10. Notwithstanding said repeal anything done or any action taken under the principle Act shall be deemed to have been done or taken under the corresponding provisions of this Act.
